

**IN SUPPORT OF RESTORATION OF FULL FUNDING FOR THE UNITED STATES
AGENCY FOR INTERNATIONAL DEVELOPMENT**

A Resolution of Witness

1 **TEXT OF THE MOTION**

2
3 **WHEREAS** the United States Agency for International Development (USAID) is the international
4 humanitarian and development arm of the U.S. government which assists in countries facing the
5 greatest needs by alleviating poverty, starvation, disease and other crises¹; and

6
7 **WHEREAS** USAID was established by then-President John F. Kennedy in 1961 as an
8 independent agency, with the two-pronged goal of countering Soviet influence during the Cold
9 War and running various foreign assistance programs²; and

10
11 **WHEREAS** USAID delivers billions of dollars annually in humanitarian aid overseas in funding
12 that provides a critical lifeline to more than 100 countries at only a small fraction of the overall
13 U.S. federal budget³; and

14
15 **WHEREAS** the more than \$40 billion in combined appropriations managed by USAID in fiscal
16 year 2023 amounted to less than 1% of the federal budget⁴; and

17
18 **WHEREAS** in fiscal year 2023, USAID provided assistance to about 130 countries with the top 10
19 recipients being Ukraine, Ethiopia, Jordan, Congo, Somalia, Yemen, Afghanistan, Nigeria, South
20 Sudan & Syria⁵; and

22 **WHEREAS** because American security is tied to stability and economic advancements in other
23 nations, the United States has more than a mere altruistic interest in supporting USAID whose
24 programs address a wide range of needs, from women's health to clean water in vulnerable nations
25 around the world⁶; and

26
27 **WHEREAS** investment in USAID's humanitarian program is a far more cost-effective
28 peacekeeping tool than military spending⁷; and

29
30 **WHEREAS** in recent years, USAID has also provided significant humanitarian and economic
31 support to Ukraine and countries affected by Russia's invasion, as well as humanitarian assistance
32 in the Gaza Strip⁸; and

33
34 **WHEREAS** the freeze on support for USAID puts millions of children and adults at mortal risk by
35 abruptly cutting off lifesaving HIV treatment and malaria prevention programs, particularly in sub-
36 Saharan Africa⁹; and

37
38 **WHEREAS** while USAID programs are suspended, shipping containers packed with lifesaving
39 antibiotics and antimalarial drugs are being held at the Port of Sudan, essential medicines are
40 expiring in the Democratic Republic of the Congo and 33,000 metric tons of American-grown
41 soybeans intended to treat severe malnutrition overseas are being diverted to warehouses where
42 they may rot or be destroyed by vermin before they reach those in need¹⁰; and

44 **WHEREAS** as Christ reminds us in Matthew 25:40, “whatever you did unto the least of these, you
45 did unto me”; and

46
47 **WHEREAS** recent Executive Branch decisions have paused or altogether terminated USAID’s
48 humanitarian as well as conservation efforts in places of great need¹¹; and

50 **WHEREAS** through the Parable of the Good Samaritan in the Gospel of Luke, Christ taught us to
51 love our neighbors as we love ourselves

52
53 **THEREFORE BE IT RESOLVED** that the Thirty-Fifth General Synod of the United Church of
54 Christ considers it a moral imperative that our nation honor its commitment to assist in meeting the
55 needs of our less fortunate neighbors insofar as it is within our ability to do so.

57 **BE IT FURTHER RESOLVED** that the Thirty-Fifth General Synod of the United Church of
58 Christ declares United States Agency for International Development (USAID) program
59 implementation, with its “world peace dividend,” represents both a moral responsibility and a
60 sound use of tax dollars.

61
62 **BE IT FURTHER RESOLVED** that the Thirty-Fifth General Synod of the United Church of Christ
63 acknowledges historical and political challenges exist related to the implementation of USAID’s
64 mission, but recognizes that USAID has provided essential, life-saving public health and
65 humanitarian aid to marginalized communities around the globe.

66
67 **BE IT FURTHER RESOLVED** that the Thirty-Fifth General Synod of the United Church of
68 Christ calls on the U.S. Congress to continue full funding for USAID.

69
70 **BE IT FURTHER RESOLVED** that the Thirty-Fifth General Synod of the United Church of
71 Christ calls on the presidential administration to immediately restore the distribution of US foreign
72 aid from the direct control of the U.S. Department of State to USAID, release any and all
73 restrictions on the ability of USAID and its administrators to fully implement its programs, and
74 seek programmatic independence for federally funded humanitarian assistance.

76 **BE IT FINALLY RESOLVED** that the Thirty Fifth General Synod of the United Church of
77 Christ calls on the presidential administration to expedite USAID delivery of food, medicine, and
78 other humanitarian supplies to those deemed to be in immediate need.

79
80 **FUNDING:** Funding for the implementation of the resolution will be made in accordance with the
81 overall mandates of the affected ministries and the funds available.

82
83 **IMPLEMENTATION:** The Officers of the Church, in consultation with appropriate ministries or
84 other entities within the United Church of Christ, will determine the implementing body.
